### Important Updates

We have been informed by government that the internal approval processes have begun. **At this point we are on track to begin registration with the College in November of 2020!**

We will be posting Registration information on the College website the week of October 13-16, 2020. Please read this information and prepare for Registration. Please note this is a Transition registration for the period of November 2020 – March 31, 2021. The annual registration renewal for the 21/22 practice year will take place in February 2021. Please contact us if you have any questions.

The requirement for the Transition Registration is to be in "good standing" with Manitoba Health, Seniors and Active Living (MHSAL). This means you must have submitted your Manitoba Continuing Competency Program for Paramedics Program (MCCPP) to MHSAL as required. New continuing competency requirements for the 2021-22 renewal year have been approved by the College's Transitional Council. A summary of the key changes will be posted on the website the week of October 13-16, 2020.

## PREPARATION CHECKLIST FOR REGISTRATION

The College is expecting to be able to accept Registrations for the issuance of Certificates of Practice in ~November 2020. In preparation for Registration please ensure the following:

- 1) You have read the Registration Changes pdf on the College website:

- 2) Your email address on record with the EMS Branch is correct as you will receive an email notification when Registration begins
- 3) You are in good standing with the EMS Branch: Your license is current and your MCCPP (Manitoba Continuing Competency Program for Paramedics) is up to date
- 4) You have taken out professional liability insurance and have the certificate saved on your computer to upload it into the registrant portal
- 5) You have a Mastercard Debit or Credit Card OR you have a Visa Debit, or Credit Card to pay the registration fee
