Bylaw Survey

Thank you to the 433 registrants who completed the Bylaw Survey. Governance committee have been meeting and considering the feedback. Suggestions for revision to the bylaws will be presented to Council at the June 21, 2023 meeting. The bylaws will then be emailed to registrants and posted on the College website for review and comment for a 30 day period. Governance committee will then consider whether to make any further changes to the bylaws. Registrants will be able to vote on the bylaws electronically September 11-15, 2023. Reminders will be provided. The results of the vote on the bylaws will be provided at the AGM on September 27, 2023.

Probe Research Survey

Thank you to the 457 registrants who completed the survey sent from Probe Research. The College is awaiting the survey results to be received from Probe and then analysis will take place on the feedback received. The information will be used to create the stakeholder and engagement communication plan for the 2023-24 year, after approval by Council. Spotlight on Delegation of Reserved Acts Practice Direction

The Practice Direction on Delegation is found here. Fast facts about delegation:

- Under the RHPA paramedics do not work under a purely delegated model, under the license of a Physician, as they did prior to self-regulation. Paramedics are independently responsible for their own practice, but are required to work within the employer scope of work and clinical guidelines/care maps/employer policies
- A delegation from one paramedic to another is based on a one-time only basis and is specific to the individual patient situation. Delegation between paramedic registrants is permitted as follows:
 - A CCP may delegate to an ACP, PCP-IC, or PCP
 - o An ACP may delegate to a PCP-IC or PCP
 - o A PCP-IC may delegate to a PCP
- A Physician may delegate to a CCP, ACP, PCP-IC, or PCP, on a one-time basis only and specific to the individual patient situation
- Please note the requirements for a professional making the delegation and for the paramedic who accepts the delegation that begins on page 6 of the practice direction
- All delegations must be documented
